DUTIES AND RESPONSIBILITIES:

- Supervises care of the babies to include feeding, dressing, playing with, reading to, and putting them to sleep
- Assists residents in primary parental responsibilities to include childcare, household tasks and safety precautions
- Trains residents in proper procedure to conduct household duties
- Assists the Program Manager in enforcing the rules of the home and offers personal and professional guidance to the residents
- Assists the Resident Program Manager with drug screening residents in accordance with established protocols
- Distributes and monitors prescribed evening and night-time medications
- Checks in with residents regularly to ensure their well-being and addresses concerns as needed
- Conducts devotionals with residents on a daily basis and provides spiritual encouragement
- Transports residents to various appointments and activities as needed
- Organizes events for residents as instructed and assists with execution
- Spends quality time with residents, to include individual talks, group discussions, watching appropriate movies/shows, playing games, or participating in any other activity that supports residents' growth and development
- Assists with maintaining records involving residents' progress
- Participates in hurricane, fire and other disaster preparation training and drills
- Secures the doors and windows of the facility at nights.

ADDITIONAL DUTIES:

- Performs other related duties and assumes other responsibilities as necessary or as delegated.

QUALIFICATION AND EXPERIENCE:

- High School diploma or equivalent, supplemented by a minimum of two (2) years resident advising experience
- CPR/AED and Behavioral Management Crisis Prevention (BMCP) certification
- In-house Florida Association of Christian Child Caring Agencies (FACCA) training certification
- Valid driver's license

Necessary Knowledge, Skills, & Abilities

- Ability to communicate effectively both verbally and in writing (basic competence with MS Word), to compose accurate correspondence, and resolve routine issues
- Advanced communications and reading skills
- Ability to multi-task to ensure daily and weekly deadline schedules are met
- Ability to work cohesively in a team-oriented, collaborative environment
- Demonstrated open-mindedness and welcoming of individual differences, to include race, cultures, religions, and economic backgrounds
- Demonstrated friendly disposition to facilitate interaction with and supervision of residents.

QUALIFICATION AND EXPERIENCE:

- Required to work nights and weekends
- Required to travel to local appointments and activities with residents and assist with activities in an outdoor environment
