Dear Friend of Hannah's Home,

We are delighted that you will be joining us on Thursday, February 3rd for our annual gala, ***Faith is our Foundation***. Prepare yourself for exciting raffle trees that appeal to everyone including those tailored for men, women and the Epicurean. In addition, our silent auction will offer items ranging from a "Be My Valentine" gift basket to a certificate for a golf foursome at Tequesta Country Club. Our live auction will feature an all-day fishing charter for eight aboard a 92' Viking fishing yacht and an all-terrain EZ-GO golf cart that seats four individuals. Finally, the ***Bid from the Heart***, will allow you to pick what you wish to support at Hannah's Home. You could underwrite the construction of a Hannah's Home duplex cottage or sponsor a mother and her baby for one year. Once again, there is something for everyone.

Hannah's Home has been a fixture in northern Palm Beach County for over 12 years. Since our doors opened, we have been blessed to facilitate the births of 68 babies through our current eight-room facility. Unfortunately, we have turned away nearly 2000 women due to a lack of capacity. The reality is that the demand to help more women in need continues to grow daily. We must expand beyond our eight-room operation.

We are pleased to announce we have recently launched a two-phased capital development campaign. Our focus for Phase I is to construct four independent living duplex cottages at an investment of \$350K per cottage totaling a \$1.4M budget. Phase II includes the construction of a 15-room dormitory building with an associated campus infrastructure that includes a driveway, drainage, furniture, fixtures, etc. This is a total investment budget of \$10.5M.

Since our recent campaign launch, we have raised \$150K towards our goal. Efforts to establish a matching grant program are underway. All proceeds from our annual gala, ***Faith is our Foundation***, will go towards our goal to house up to 24 women and their babies.

Over the years, we have been stalwarts of financial stewardship. Hannah's Home remains debt-free having paid off our \$550K mortgage in full. Our annual operating budget is \$375K. We currently have approximately \$275K in operating funds. The Mary L. Evans & Elizabeth W. Evans Endowment fund recently finished its first year with an accumulated balance of \$444K.

These are exciting times for Hannah's Home. However, your continued support and investment is absolutely critical to our growth and success.

We are extremely grateful for your partnership in this journey to save women and babies for the many generations to come.
